Support for operations ensures we can responsibly manage charitable funds, award grants, strengthen nonprofits, and respond to the evolving needs of Southwest New Mexico.

Emergency Relief & Community Assistance Funds (Trout Fire Relief & Food Insecurity Response) The Gila Community Foundation administered emergency relief funds to support individuals and families affected by wildfire impacts and food insecurity in Southwestern New Mexico. Funds were raised from community donors and distributed to qualified nonprofit partners and service providers to assist residents with essential needs including food, housing support, emergency supplies, and recovery assistance. Relief efforts included support related to the Trout Fire emergency response and community food insecurity assistance during periods of economic hardship. A total of 324 individuals received direct or indirect assistance through funded programs and services. Total program expenses were \$31,683.99
